### TREASURER'S REPORT

Shanta said we now have an available balance of approx \$3,300 in our account.

## **EWB AND USM**

Brandon said it's been quiet over the holidays; no news to share. He will re-establish contact and have an update for us in February.

Will has coordinated with the Maine Engineering Promotion Council regarding the 2011 Maine Engineers Week Exposition which will be held at the USM Field House in Gorham on Saturday February 19, 2011 from 9 AM to 2 PM. At this exposition, Maine's top engineering firms, engineering schools, educators, government agencies, industry, and engineering societies will exhibit throughout the field house. We will co-exhibit with EWB-UM, and therefore there will be no registration/booth fee. Way to go Will! This will be a key topic of discussion at our next meeting, as we'll be looking for volunteers to work the booth.

## GHANA PRE-ASSESSMENT TRIP APPLICATION

<u>521 Pre-Assessment Trip Application</u> - Shanta said we have a good draft of the application. People involved will be wrapping their sections up. Once complete, he will resend to

everyone for review. In order to travel sometime in March (actual dates TBD), the deadline for submittal to EWB-USA is Jan 16<sup>th</sup>.

<u>March Travel Team</u> - Folks planning to travel in March include Nadia, Scott, Jay, Karen Arnold, Sara, and Jake.

Costs – Jay has developed approximate costs for the trip. He said that six people traveling for 14 days would be approximately \$13,000 incl airfare. If the length of trip is reduced to 8010 days, the chapter travel costs would \$5600 plus \$1400 for materials for rainharvesting system.
